Registration Requirements and Information

Show date: June 14th, 2008 – 9am to 5pm

Definition: A quilt is two layers of fabric with a filling that is stitched together with patterns or lines. Quilting must be done by hand or machine. Tied quilts, "Raggy" quilts and quilts made from predominately preprinted panels will not be allowed in this show.

Size: Each quilt must be at least 36 x 36 inches and no larger than 104" in width or length. Stuffed animals, pillows, pillow cases, etc. are not allowed. Shapes other than squares or rectangles will not be allowed due to difficulty in hanging.

Label: Quilts must have a fabric label stitched to the back of each quilt, at or near a bottom corner. The label should include the "quilt title" and exhibitor's name.

Registration and Registration Requirements: All quilts entered in the Templeton Outdoor Quilt Show™ must be registered. Registrations are accepted on a first-come, first served basis. A Registration Form is required for each quilt shown. Please download additional original Registration Forms at: www.templetonquiltshow.com. You may also photocopy additional needed forms, double-sided copying, so to include this page and the Release Agreement in the next column.

The Registration Form serves as the show tag while the quilt is on display and must be completed *in its entirety*. The Templeton Outdoor Quilt Show™ is based on a "show and tell" format and the Quilt Facts are how you tell the show visitors about your quilt.

A 4x6 clearly focused photograph of your quilt *must accompany* each registration form.

Each exhibitor is also required to sign the Liability Release Agreement located in the next column.

Incomplete registration forms will be mailed back for completion.

Registration Deadline: *May 1, 2008 is the deadline for receipt of Registration Forms.* Please mail forms to

Quilts are officially registered when completed Registration Forms are received, not requested. *Quilts must arrive no later than June 7th, 2008.* Exceptions can be made to this deadline, however, please call Sue Geiger at 805-466-1207 to obtain approval for a quilt-deliver-deadline exception.

Sale Quilts: Limited to 7 quilts per person. The Templeton Outdoor Quilt Show™ **retains 20% of sales price** on sold quilts to help defray show expenses. Please price sale quilts accordingly.

or enclose a self-addressed, stamped postcard or envelope with your completed registrations materials.

Insurance: In the very unlikely event that a quilt is lost or damaged, Templeton Outdoor Quilt Show™ cannot be held responsible. Accordingly, insurance is the responsibility of the quilter/owner. Customs and/or brokerage fees are the responsibility of the individual.

Photography: Submission of a quilt to the Templeton Outdoor Quilt Show™ constitutes permission by the quilter/owner to allow it to be photographed by show attendees and the media, but may not be used for commercial purposes by these parties.
